Highlights

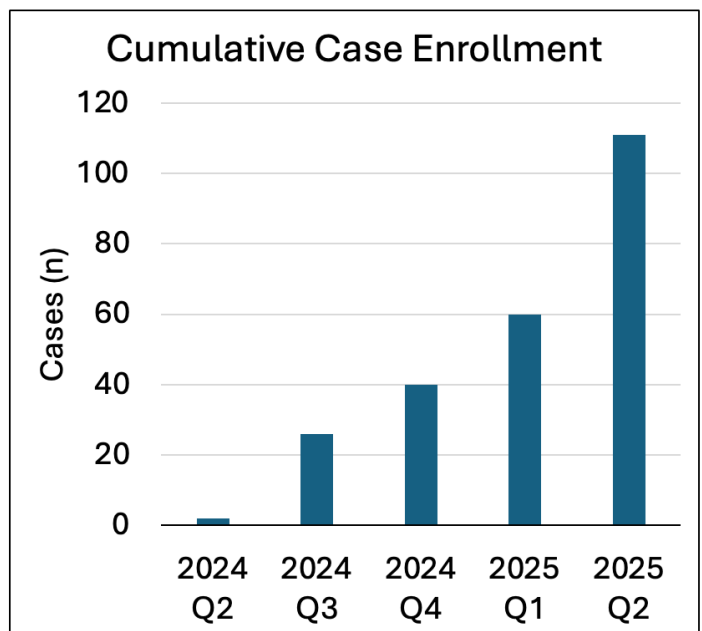
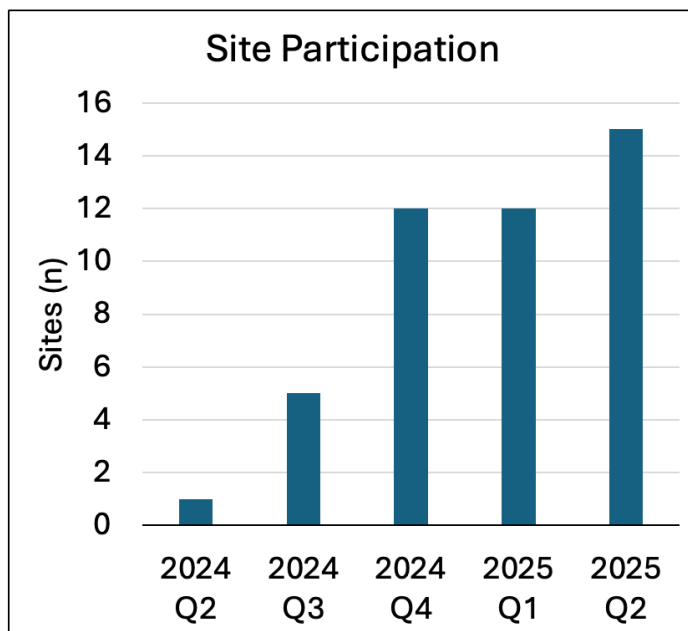
- **Major Milestone Achieved:** The PFR Registry has now enrolled **over 100 cases** across 12 participating institutions.
- **Rapid Growth:** **51 new cases** were added in the past three months alone.
- **Webinar Success:** The inaugural PFR Registry webinar drew **110 registrations**, with 82 attendees. Post-event evaluations were **overwhelmingly positive** (70% rated it excellent, 30% good).
- **Rising Interest:** Following the webinar, **over 30 additional institutions** have expressed strong interest and are actively progressing through the participation process.

- **December 2025:** The **next PFR Registry webinar** is scheduled—details to follow.
- **PDA Stenting Conference (San Diego):** The registry has been invited to present preliminary outcomes from the first 100 enrolled cases.
