

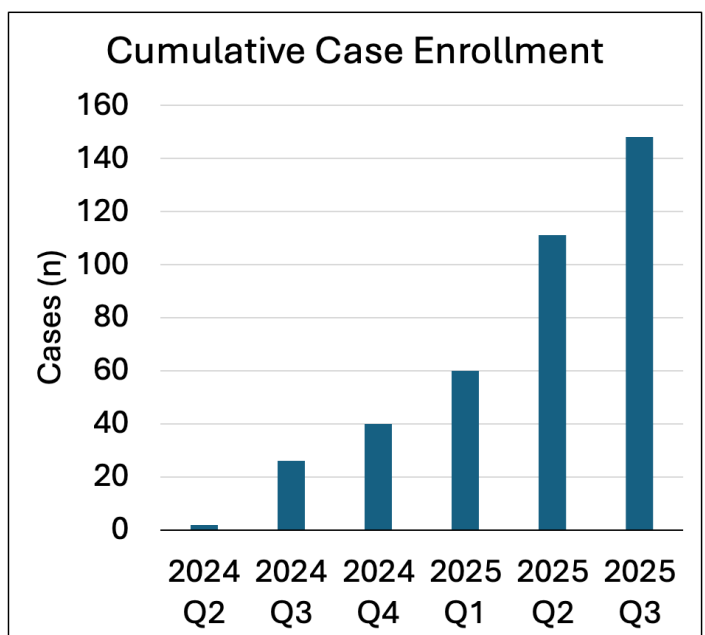
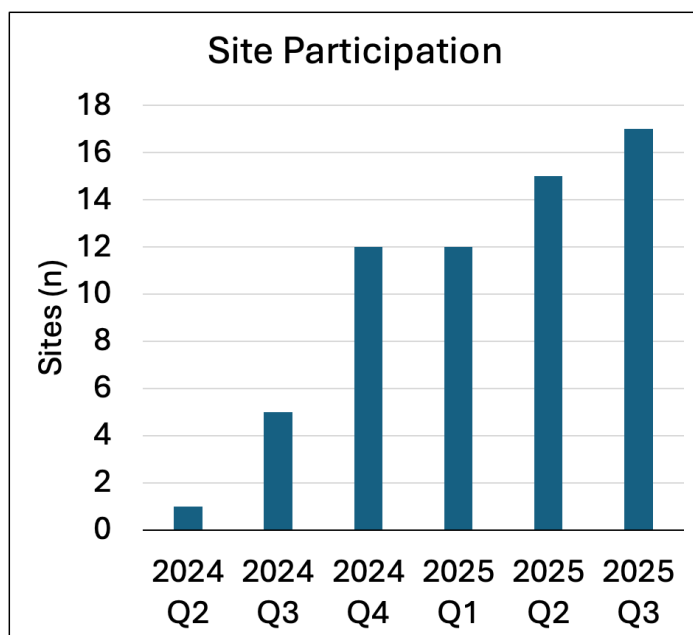


PFR Registry Newsletter

Pulmonary Flow Restrictor Registry Ver. 1.1

Highlights

- The **PFR Registry** has enrolled **148 cases across 17 participating centers**, with an additional **32 centers currently in the process of joining**.
- The **number of PFR procedures continues to increase**, with **2025 marking the highest annual enrollment** to date.
- **Top enrolling centers** include:
 - **Phoenix Children's Hospital** (n = 27)
 - **St. Louis Children's Hospital** (n = 23)
 - **Children's Hospital of Alabama** (n = 22)
 - **Columbia University New York-Presbyterian** (n = 15)
 - **Children's Hospital Los Angeles** (n = 13)
- **Dr. Daisuke Kobayashi** delivered an invited lecture titled "*The Art of Restriction: Data-Driven Outcomes from Pulmonary Flow Restriction*" at the **PDA Stenting Symposium 2025** in San Diego on **October 31, 2025**, where preliminary PFR Registry data were presented.
